What is the overall deductible? The <u>deductible</u> is Embedded . If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> . Are there services covered before you meet your deductible?	Yes. Preventive care services are covered before you meet your deductible.
